# THE MARRIAGE (FEES) ORDER, 2013 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 55 OF THE MARRIAGE ACT (CAP. 05.01).

### 1. Citation and commencement

This Order may be cited as the Marriage (Fees) Order 2013 and comes into force on the 1st day of April, 2013.

### 2. Fees to be paid for the performance of duties and services

The following fees are payable for the performance of the duties and services to which they relate—

### Fees

(1)	For every entry, certificate and publication in relation to the registration of a building for the publication of banns, on delivery of the application to register, under section 17 of the Act	\$200.00
(2)	For every cancellation or substitution of registration of a building, on delivery of the certificate for cancellation or substitution, under section 30 of the Act	\$200.00
(3)	For every certificate of publication of banns given by the officiating Minister, payable to the officiating Minister, under section 31 of the Act	\$50.00
(4)	For every entry in the Marriage Notice Book, under section 41 of the Act	\$50.00
(5)	For every Certificate of Notice, under section 43 of the Act	\$50.00
