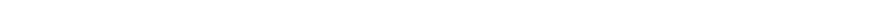

**BILLS OF SALE (PAYMENT OF FEES) ORDER**

**THE BILLS OF SALE (PAYMENT OF FEES ORDER, 2013 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 16 OF THE BILLS OF SALE ACT (CAP. 15.14).**

**1. Short title and commencement**

This Order may be cited as the Bills of Sale (Payment of Fees) Order 2013 and comes into force on the 1<sup>st</sup> April, 2013.

**2. Fees payable**

The following fees shall be paid and received in stamps—

- (c) and when such consideration money exceeds the sum of \$10,000.00 \$400.00
- (d) on the affidavit or instrument used for the purpose of reregistering or discharging a bill of sale or bills of sale, in respect of each bill of sale so re-registered or discharged—
  - (i) when the consideration money does not exceed the sum of \$5,000.00; \$100.00
  - (ii) when the consideration money exceeds the sum of \$5,000.00. \$200.00

**3. Repeal**
