**THE CUSTOMS DUTIES AND CONSUMPTION TAX (JAY STEED AND
CHARLENE BARTLETT) (EXEMPTION) ORDER 2016 MADE BY THE
GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER
SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX
ACT (CAP. 17.05).**

1. Citation

This Order may be cited as the Customs Duties and
Consumption Tax (Jay Steed and Charlene Bartlett) (Exemption)
Order, 2016.

2. Exemption

Subject to paragraph 3, Jay Steed and Charlene Bartlett, trading
as ICE, are exempted from the payment of customs duty and
consumption tax on the importation of the items listed in the
Schedule.

3. Conditions

The grant of the exemption under paragraph 2 is subject to the
conditions that Jay Steed and Charlene Bartlett—

- (a) submit documentary evidence to the Montserrat Tourist
Unit that they are—
 - (i) engaged in marketing activities on the international
market; and
 - (ii) certified as members of the Professional
Association of Diving Instructors;

- (b)* make an undertaking in writing to—
 - (i)* preserve the marine resources in Montserrat; and
 - (ii)* educate its staff and customers of ICE on the preservation of Montserrat's marine resources; and
- (c)* submit annual financial statements to the Inland Revenue Department.

4. Duration

The exemption granted under paragraph 2 is valid for a period of five years from the commencement of this Order.
