**(VETA WADE) (EXEMPTION) ORDER**

**THE CUSTOMS DUTIES AND CONSUMPTION TAX (VETA WADE) (EXEMPTION) ORDER 2017 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Veta Wade) (Exemption) Order, 2017.

**2. Exemption**

Veta Wade, trading as AQUA Montserrat, is exempted from the payment of customs duty and consumption tax on the importation of—

- (a) one Suzuki Grand Vitara XL with roof bars (Car registration HJ53WLB 2.7L petrol); and
- (b) the items listed in the Schedule.

**3. Conditions**

The exemption under paragraph 2 is valid for a period of two years from 8 March, 2017 to 7 March, 2019.
