CUSTOMS DUTIES AND CONSUMPTION TAX
(JOHN OSBORNE) (EXEMPTION) ORDER

THE CUSTOMS DUTIES AND CONSUMPTION TAX (JOHN OSBORNE) (EXEMPTION) ORDER 2014 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 17 (2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (John Osborne) (Exemption) Order, 2014.

2. Exemption

John Osborne is exempted from the payment of customs duties and consumption tax on the importation of performance parts and specialized fuel for the motor vehicle specified in the Schedule.

3. Conditions

- (1) A list of the items to be imported under paragraph 2 must be submitted to and approved by the Chief Mechanic in the Ministry of Communications and Works before importation.
- (2) The specialized fuel to be imported under paragraph 2 must not exceed fifteen imperial gallons.
- (3) The exemption under paragraph 2 is valid for five years after the commencement of this Order.
