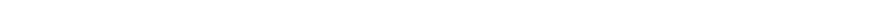

(IVOR GREENAWAY) (EXEMPTION) ORDER

THE CUSTOMS DUTIES AND CONSUMPTION TAX (IVOR GREENAWAY) (EXEMPTION) ORDER 2016 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOM DUTIES AND CONSUMPTION TAX ACT (CAP.17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Ivor Greenaway) (Exemption) Order, 2016.

2. Exemption

Ivor Greenaway, trading as iTECH, is exempted from the payment of customs duty and consumption tax on the importation of the items listed in the Schedule.

3. Condition

The exemption under paragraph 2 is for a period of three years after the commencement of this Order.
