PUBLIC FINANCE (MANAGEMENT AND ACCOUNTABILITY) (PROCUREMENT) (AMENDMENT) REGULATIONS 2016

THE PUBLIC FINANCE (MANAGEMENT AND ACCOUNTABILITY) (PROCUREMENT) (AMENDMENT) REGULATIONS MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 58 OF THE PUBLIC FINANCE (MANAGEMENT AND ACCOUNTABILITY ACT (CAP. 17.07).

1. Citation

These Regulations may be cited as the Public Finance (Management and Accountability) (Procurement) (Amendment) Regulations, 2016.

2. Regulation 23 amended

Regulation 23 of the Public Finance (Management and Accountability) (Procurement) Regulations (Cap. 17.07) is amended—

- (*a*) by deleting the chapeau to the regulation and substituting the following—
 - "23. (1) A procuring entity may engage in single-source procurement if—";
- (b) by inserting the following as subregulations (1)(da) and (1)(db)—
 - "(*da*) owing to an extreme emergency resulting from an unforeseeable event, there is an urgent need for goods, services or works and it is impractical to use the other methods of procurement, due to the time involved in using those methods;"
 - (db) no tenders were received or no suitable tender has been submitted in response to an invitation to tender and it is impractical to use the other methods of procurement, due to the time involved in using those methods;" and

- (c) by inserting the following as subregulation (2)—
 - "(2) If a procurement is undertaken under subregulation (1)(da),—
 - *(a)* the procurement contract is limited to the goods, services or works necessary to deal with the extreme emergency; and
 - (*b*) the remaining goods, services and works shall be procured using one of the other prescribed methods of procurement.".
