**REGULATIONS**

*(Section 2)*

**THE CUSTOMS (AFTER HOURS WORK) (FEES) (AMENDMENT) REGULATIONS, 2013 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 2 OF THE CUSTOMS (AFTER HOURS WORK) ACT (CAP. 17.23).**

**1. Citation and commencement**

These Regulations may be cited as the Customs (After Hours Work) (Fees) (Amendment) Regulations 2013 and come into force on the 1st May, 2013.

**2. Interpretation**

In these Regulations “**principal Regulations**” means the Customs (After Hours) (Fees) Regulations (Cap. 17.23).

**3. Regulation 5 amended**

The principal Regulations is amended by deleting regulation 5 and substituting the following:

**“5. Fees**

- (1) An hourly rate fee as set out in the Column 3 shall be charged for in respect of each custom officer employed before or after the usual office hours for the purposes of providing the service set out in Column 2 on the days specified in Column 1 —

- (2) A minimum charge for 2 hours is payable respect of each officer for the service provided under paragraph 1.”

**4. Regulation 6 amended**

The principal Regulation is amended by deleting regulation 6 and substituting the following:

**“6. Landing goods elsewhere than at Port Little Bay**

Where application is made to land or load goods elsewhere than at Port Little Bay the sum of \$1200 per day up to a maximum of 10 hours shall be paid in advance to the Comptroller of Customs and Excise for the services and expenses for the customs officers in attendance.”
