**CUSTOMS DUTIES AND CONSUMPTION TAX (SHARRA  
GREENAWAY) (EXEMPTION) ORDER 2015 MADE BY THE  
GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER  
SECTIONS 7(3) AND 19(2) OF THE CUSTOMS DUTIES AND  
COMSUMPTION TAX ACT (CAP.17.05).**

**1. Citation**

This Order may be cited as Customs Duties and Consumption Tax (Sharra Greenaway) (Exemption) Order, 2015.

**2. Exemption**

Sharra Greenaway, trading as Davy Hill Medical Centre, is exempted from the payment of custom duties and consumption tax on the importation of the following items -

- (a) two air conditioning units;
- (b) one mammogram machine and ancillary parts;
- (c) one ultrasound machine and ancillary parts; and
- (d) two back up power systems.

**3. Condition**

The exemption granted under paragraph 2 is subject to the payment of the following -

- (a) a 5% processing fee on the value of the two air conditioning units; and
- (b) a 2% processing fee on the value of the mammogram machine and ancillary parts, ultrasound machine and ancillary parts and the two back up power systems.
