**THE CUSTOMS DUTIES AND CONSUMPTION TAX (ICT PROJECT GRANT SCHEME) (EXEMPTION) ORDER 2015 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTIONS 8(2) AND 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (ICT Project Grant Scheme) (Exemption) Order, 2015.

**2. Exemption**

A person listed in the Schedule is exempted from the payment of—

- (a) customs duties;
- (b) consumption tax; and
- (c) processing fee

on the importation of items necessary for the implementation of his or its ICT Project Proposal approved by the Ministry of Communications, Works and Labour under the ICT Project Grant Scheme.

**3. Condition**

A list of the items to be imported under paragraph 2 must be submitted to and approved by the Director with responsibility for Information and Communications Technology within the Ministry of Communications, Works and Labour prior to importation.
