THE CUSTOMS DUTIES AND CONSUMPTION TAX (POOL KING LTD.) (EXEMPTION) ORDER 2017 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Pool King Ltd.) (Exemption) Order, 2017.

2. Exemption

Pool King Ltd. is exempted from the payment of customs duties and consumption tax on the importation of the items listed in the Schedule.

3. Expiration

The exemption granted under paragraph 2 expires one year after the commencement of this Order.
