THE CUSTOMS DUTIES AND CONSUMPTION TAX (REDUCTION OF CUSTOMS DUTIES AND CONSUMPTION TAX) (CHRISTMAS BARRELS) ORDER 2015 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(1) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

### 1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Reduction of Customs Duties and Consumption Tax) (Christmas Barrels) Order, 2015.

# 2. Reduction of Customs Duties and Consumption Tax

Subject to paragraph 3, customs duties and consumption tax payable on a barrel is reduced to \$30.

# 3. Conditions

- (1) The reduction of customs duties and consumption tax under paragraph 2 is—
  - (a) applicable to a barrel imported into Montserrat commencing on 26 October 2015 and ending on 31 January 2016; and
  - (b) on a maximum of two barrels per household.
- (2) A person who sells an item imported under subparagraph (1) shall pay to the Comptroller of Customs and Excise the customs duties and consumption tax waived under paragraph 2 on that item.
