**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Rickford Archer) (Exemption) Order, 2015.

**2. Exemption**

Rickford Archer, trading as The Umpire, is exempted from the payment of customs duty and consumption tax on the importation of the items listed in the Schedule valued at approximately \$44,891.20.
