MERCHANT SHIPPING (REGISTRATION FEES)
REGULATIONS 2014

THE MERCHANT SHIPPING (REGISTRATION FEES) REGULATIONS 2014 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTIONS 52 AND 60 OF THE MERCHANT SHIPPING (REGISTRATION) ACT 2013 (NO. 23 OF 2013).

1 Citation

These Regulations may be cited as the Merchant Shipping (Registration Fees) Regulations 2014.

2 Interpretation

In these Regulations “Act” means the Merchant Shipping (Registration) Act 2013 (No. 23 of 2013).

3 Fees

The fee for a ship registration service specified in column 2 of the Schedule is payable at the rate specified in column 3 of the Schedule.

4 First registration fee non-refundable after issue of carving and mark

If the Registrar issues a carving and marking note in relation to a ship, the fee paid on application for first registration is non-refundable.

5 Payment of annual fee

- (1) The annual fee for maintenance of the Register specified in the Schedule is payable on the anniversary of the date of registration of a ship.

- (2) An owner of a ship registered under the Act shall ensure that the fee prescribed under subregulation (1) is paid.
- (3) The Registrar shall terminate the registration of a ship if the Registrar is satisfied that an owner has failed to pay the fee prescribed under subregulation (1) within ninety days of the anniversary of the date of registration of a ship.
