#### 1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Toddlers and Tweens Boutique Plus) (Exemption) Order, 2012.

## 2 Exemption

Earl Sullivan trading as Toddlers and Tweens Boutique Plus is exempted from the payment of customs duty and consumption tax on the importation of the following items:
