CUSTOMS DUTIES AND CONSUMPTION TAX
(OVEN LINDSEY) (EXEMPTION) ORDER

THE CUSTOMS DUTIES AND CONSUMPTION TAX (OVEN LINDSEY) (EXEMPTION) ORDER 2015 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Oven Lindsey) (Exemption) Order, 2015.

2. Exemption

Oven Lindsey trading as Mystique of Montserrat is exempted from the payment of customs duties and consumption tax on the importation of the items listed in the Schedule.

3. Duration

The exemption granted under paragraph 2 is valid for one year and six months from the commencement of this Order.
