**THE CUSTOMS DUTIES AND CONSUMPTION TAX (MONTSERRAT BOTTLING COMPANY LTD.) (EXEMPTION) ORDER 2015 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 17(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Montserrat Bottling Company Ltd.) (Exemption) Order, 2015.

**2. Exemption**

Montserrat Bottling Company Ltd. is exempted from the payment of Customs Duty and Consumption Tax on the importation of the following items:

- (a) glass bottles;
- (b) bottle caps;
- (c) bottle lids;
- (d) bottle crates;
- (e) labels;
- (f) pasteurizing equipment;
- (g) pasteurizing stills;
- (h) carbon dioxide tanks;
- (i) carbon dioxide refills;
- (j) water filters UV treatment units;
- (k) water storage tanks;
- (l) pumps fittings; and
- (m) capping levers bottle washers.
