**AN ACT TO SANCTION A PAYMENT FROM THE DEVELOPMENT FUND IN EXCESS OF THE SUMS PROVIDED BY LAW FOR THE SERVICES OF THE GOVERNMENT OF MONTSERRAT FOR THE PERIOD ENDING ON THE THIRTY-FIRST DAY OF MARCH, 2015.**

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Montserrat and by the Authority of the same as follows:—

**1. Short title and commencement**

This Act may be cited as the Supplementary Appropriation (No. 4/2014) Act 2015, and shall be deemed to have come into force on the first day of April 2014.

**2. Authorisation of Expenditure**

The sum of five hundred and sixty-one thousand eight hundred dollars (\$561,800) set out in the Schedule to this Act in addition to the sums granted by the Appropriation Act 2014 (No. 4 of 2014), is declared to be charged upon and made payable from the development fund of Montserrat, and the Accountant General is hereby authorised and required from time to time on the authority of warrants issued under the hand of the Minister of Finance to pay the sum set out in the Schedule to the service mentioned as the warrants may direct out of the development fund of Montserrat without further order or formality.
