**The Liberia and Côte d'Ivoire (Sanctions) (Overseas Territories)  
(Revocations) Order 2016**

At the Court at Buckingham Palace, the 13th day of July 2016

Present,

The Queen's Most Excellent Majesty in Council

Under article 41 of the Charter of the United Nations, the Security Council of the United Nations has, by resolutions adopted on 28th April 2016 and 25th May 2016, terminated the measures adopted in respect of Côte d'Ivoire and Liberia respectively:

Her Majesty, in exercise of the powers conferred on Her by section 1 of the United Nations Act 1946(a), section 112 of the Saint Helena Act 1833(b), the British Settlements Acts 1887 and 1945(c), and all of the other powers enabling Her to do so, is pleased, by and with the advice of Her Privy Council, to order as follows:

**Citation, commencement and extent**

**1.**—(1) This Order may be cited as the Liberia and Côte d'Ivoire (Sanctions) (Overseas Territories) (Revocations) Order 2016 and comes into force on 10th August 2016.

(2) This Order extends to the territories listed in the Schedule.

**Revocations**

**2.** The following Orders are revoked:

- (a) the Côte d'Ivoire (Sanctions) (Overseas Territories) Order 2012(d); and
- (b) the Liberia (Sanctions) (Overseas Territories) Order 2015(e).
