## MONTSERRAT No. 14 of 1968

AN ORDINANCE TO GIVE LEGAL EFFECT TO THE PRO-VISIONS OF THE CARIBBEAN FREE TRADE ASSOCIA-TION AGREEMENT.

Majesty, by and with the advice and consent of the Legislative Council of Montserrat, and by the authority of the same as follows:—

1. This Ordinance may be cited as the Caribbean Short Title. Free Trade Association (Ratification of Agreement) Ordinance, 1968.

2. In this Ordinance —

Interpretation

"the Agreement" means the Agreement signed on the 15th December, 1965, at Dickenson Bay, Antigua, for the establishment of a Caribbean Free Trade Association and includes the supplementary agreement for amendment of the same and rescission of a previous supplementary agreement thereto signed on behalf of the Governments of Guyana, Antigua and Barbados.

3. The Agreement establishing a Caribbean Free Ratification. Trade Area, is hereby ratified.

MONTSERRAT

Agreement to have the force of Law.

4, The provisions of the Agreement shall have the force of law as if enacted in this Ordinance.

Regulations.

5. The Administrator-in-Council may after consultation with the members of the Caribbean Free Trade Association Council of Ministers and with the approval of a Secretary of State, make regulations generally for the better carrying into effect the provisions of this Ordinance.

Commencement.

6. This Ordinance shall come into operation on the 1st day of August, 1968.
