AN ACT TO PROVIDE FOR THE EXTENSION OF LICENCES AND PERMITS AND FOR RELATED MATTERS IN RESPONSE TO THE COVID-19 PANDEMIC.

BE IT ENACTED by The Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Montserrat, and by the authority of the same as follows:—

1 Short title and commencement

This Act may be cited as the Miscellaneous Amendments Provisions (Covid-19) Act, 2020 and is deemed to come into force 1 March, 2020.

2 Extension of permits and licences etc.

Despite any provision in an Act, Regulation or Order, an Act listed in column 1 of the Schedule is amended to the extent set out in Column 2 of the Schedule.
