**PUBLIC HEALTH (COVID-19 SUPPRESSION) ORDER**

**THE PUBLIC HEALTH (COVID-19 SUPPRESSION) ORDER MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTIONS 10, 11 AND 12 OF THE PUBLIC HEALTH ACT (CAP. 14.01).**

**WHEREAS** section 10 of the Public Health Act (Cap. 14.01) (the Act) provides that where any part of Montserrat appears to be threatened with or affected by any communicable disease in epidemic proportions, and that measures apart from, or in addition to those specifically provided for in the Act should be taken promptly; and

**WHEREAS** section 10 of the Act also provides that the Governor acting on the advice of Cabinet may by order direct the enforcement of any measure he thinks expedient for removing or otherwise guarding against any such condition and the probable consequences thereof, or for preventing or mitigating as far as possible any such disease; and

**WHEREAS** section 11 of the Act provides that where there is prevalent in Montserrat or in any part thereof any communicable disease in epidemic proportions, the Governor acting on the advice of Cabinet may, by order published in a newspaper and by radio, prohibit the assembly of persons exceeding such number as may be prescribed in that order at any place specified therein, and such prohibition may be made applicable to the whole of Montserrat or to any part thereof; and

**WHEREAS** section 12 of the Act provides that where there is prevalent in Montserrat or in any part thereof, any communicable disease in epidemic proportions, and the Governor acting on the advice of Cabinet is satisfied that it is in the interest of public health to do so, he may by order published in a newspaper and by radio, direct that any public place or any school in Montserrat, or in the area in which such disease is prevalent, shall be closed for such period as he thinks necessary; and

**WHEREAS** there was an outbreak of a new infectious disease caused by the most recently discovered coronavirus (COVID-19), a respiratory disease that spreads easily from person to person, which began in Wuhan, China, in December 2019; and

**WHEREAS** the World Health Organization (WHO), on 11 March 2020, stated that the number of cases of COVID-19 outside China has increased 13-fold, and the number of affected countries has tripled; and

**WHEREAS** the WHO has declared the rapid spread of COVID-19 as a global pandemic; and

**WHEREAS** COVID-19 has resulted in 3 544 222 confirmed cases and 250 977 deaths globally to date; and

**WHEREAS** there have been 11 confirmed cases of COVID-19 on Montserrat;

**NOW THEREFORE** for the purpose controlling and suppressing the spread of COVID-19 the Governor acting on the advice of Cabinet makes the following Order:

**1. Citation and commencement**

This Order may be cited as the Public Health (COVID-19 Suppression) Order, 2020 and comes into force 7 May, 2020 at 12 a.m.

**2. Interpretation**

In this Order—

**“curfew”** means the curfew imposed by paragraph 3;

**“enforcement officer”** means a member of the Montserrat Police Service, Montserrat Defence Force, any other law enforcement officer, or a prison officer;

**“essential service provider”** means a person, business, organisation or Department that offers—

- (a) air traffic (including meteorological, telecommunication, security, fire and crash services connected with airports) services;
- (b) fire, prison, defence force or police services;
- (c) medical, health, hospital, infirmary or nursing home services;
- (d) telecommunications or broadcasting services;
- (e) water, electricity or sanitation services;
- (f) immigration, customs or postal services;

- (g) services connected with sittings of the Legislative Assembly and meetings of Cabinet;
- (h) services connected with the loading and unloading of ships and with the storage and delivery of goods at, or from a dock, wharf or warehouse operated in connection with the dock or wharf;
- (i) public services connected with the payment of salaries, pensions and other benefits, in government departments, agencies; statutory bodies and arms-length bodies;
- (j) services connected with the Judiciary;
- (k) services connected with oil-refining and with the loading, distribution; transportation or retail of petroleum fuel, liquefied natural gas or any renewable energy source;
- (l) airport, seaport, civil aviation or ferry services; or
- (m) services connected with essential government functions as determined by the Deputy Governor;
- (n) a service that is granted permission to offer the service under paragraph 15;

**“home”** in relation to a person, means the place where the person lives or occupies on the date this Order comes into force, and includes any driveway, garden or yard forming part of that place;

**“isolate”** means the removal to a hospital or other suitable place approved by the Chief Medical Officer of a person infected with or suspected to be infected with COVID-19, and his detention at the hospital or other suitable place, until, in the opinion a Medical Officer he is no longer infected with COVID-19;

**“large gathering”** means a gathering of more than four persons;

**“members of the same household”** means persons (whether or not the persons are family members) who are living at the same home;

**“Minister”** means the Minister responsible for health matters;

**“Montserratian”** has the meaning assigned to it in the Montserrat Constitution Order (Cap. 1.01);

**“public place”** includes a public highway, street, road, square, court, alley, land, bridle-way, footway, parade, wharf, jetty, quay, bridge, public garden or open space, and every theatre, place of public entertainment of any kind, or

other place of general resort, admission to which is obtained by payment, or to which the public have access;

“**self-quarantine**” means staying at one’s place of residence away from other persons for the purpose of observing and monitoring one’s health for the development of COVID-19 symptoms; and

“**social distancing**” means maintaining a physical distance of at least six feet between all persons who are not members of the same household.

**3. Curfew**

- (1) Subject to paragraph 4, a person shall not be in a public place and shall remain at home from the date and time this Order comes into force.
- (2) A person shall not be in a public place and shall remain at home on a Saturday and a Sunday.

**4. Exceptions to curfew**

- (1) A person may be in a public place between 5 a.m. and 7 p.m. on a Monday, Tuesday, Wednesday, Thursday or a Friday if the purpose for being in the public place is to—
  - (a) carry out functions as an essential service provider which includes travelling to or from work as an essential service provider,
  - (b) assist, transport or provide an ancillary service for an essential service provider,
  - (c) seek medical care,
  - (d) visit the doctor or pharmacy,
  - (e) shop for necessities to include food, medicine, fuel or other necessity, provided that only one person from each household may leave the home for this purpose,
  - (f) conduct a banking transaction or a transaction at a money transfer business provided that only one person from each household may leave the home for this purpose,
  - (g) pay utility bills provided that only one person from each household may leave the home for this purpose,
  - (h) engage in an activity to include running, walking, swimming, alone or with no more than 4 members of the same household, each day

between of 5 a.m. to 8 a.m. and 4 p.m. to 6:30 p.m. but no later than 7 p.m. and provided no motor vehicle is used to get to and from the place where the activity is being done,

- (i)* attend a funeral,
  - (j)* engage in an activity referred to in paragraph 5(1)(*n*) and (*o*), and
  - (k)* access a business or service referred to in paragraph 5(1).
- (2) Paragraph 3 does not apply to a person—
- (a)* employed to offer an essential service if that person offers the service based on a twenty-hour shift system;
  - (b)* employed to offer a service ancillary to an essential service if that person offers the service based on a twenty-hour shift system;
  - (c)* who is seeking medical attention;
  - (d)* who disembarks a vessel or airplane, provided that the person shall not be in a public place later than 11 pm;
  - (e)* who is at the airport or seaport for the purpose of transporting a person who has disembarked from a vessel or airplane, provided that the person shall not be in a public place later than 11 pm;
  - (f)* who attends the airport or seaport for the purpose of departing from Montserrat, provided that the person shall not be in a public place earlier than 4 am; or
  - (g)* who attends the airport or seaport for the purpose of transporting a person departing from Montserrat, provided that the person shall not be in a public place earlier than 4 am.
- (3) The Minister may, in exceptional circumstances, give a person written permission to be in a public place—
- (a)* between 7 p.m. to 5 a.m. on a Monday, Tuesday, Wednesday, Thursday or a Friday.
  - (b)* at any time of the day or night on a Saturday or a Sunday.
- (4) Paragraph 3(2) does not apply to—
- (a)* a doctor's office,
  - (b)* a pharmacy,

- (c) an undertaker; and
- (d) a person, business or organisation that is granted permission to operate under subparagraph (3)(b).

**5. Permitted activity Monday to Friday**

- (1) The following persons, businesses or organisations may operate on a Monday, Tuesday, Wednesday, Thursday or a Friday—
- (a) an essential service provider,
  - (b) a bank, money transfer business or insurance business,
  - (c) a doctor's office or pharmacy,
  - (d) a grocery store, bakery, wholesale business or agricultural produce business,
  - (e) a gas station,
  - (f) a business connected with fisheries,
  - (g) an undertaker,
  - (h) water, electricity, telecommunications or internet service provider,
  - (i) a mechanic or tire repair business for the purpose of offering basic motor vehicle repair services,
  - (j) a hardware store,
  - (k) a person or business that is granted a permit to carry out a construction project,
  - (l) a pool maintenance business, landscaping business, gardening or lawn cutting business,
  - (m) sand mining business,
  - (n) a tradesman to include, a plumber, an electrician, a carpenter or mason who is granted permission to assist in a construction project,
  - (o) a tradesman to include a plumber or an electrician provided the tradesman provides services for household emergencies only, and
  - (p) a business, person or organisation that is granted permission to operate by the Minister.

- (2) A person, business, organisation listed in subparagraph (1) shall cease to operate no later than 6 p.m. on a Monday, Tuesday, Wednesday, Thursday or a Friday and may resume operations no earlier than 5 a.m. on a Monday, Tuesday, Wednesday, Thursday or a Friday.

**6. Social distancing**

- (1) The owner of a business or organisation referred to in paragraph 5(1) shall—
- (a) establish measures that ensures customers and staff maintain a physical distance of at least six feet from another person both inside and outside the business or organisation;
  - (b) determine the number of persons that may be permitted to enter the business or organisation at any one time by permitting one person for every thirty square feet of floor space;
  - (c) place distance markers six feet apart, inside the business or organisation to indicate where each customer must stand at the checkout point or in a queue;
  - (d) place distance markers six feet apart, outside of the business or organisation to indicate where a customer must stand while waiting to enter the business or organisation.
- (2) A person shall practice social distancing at all times.

**7. Mandatory closures**

- (1) No person, business or organisation shall open or operate on a Saturday or a Sunday except with written permission of the Minister.
- (2) For the avoidance of doubt the following businesses or persons shall not operate—
- (a) a bar or nightclub,
  - (b) a restaurant, to include take-away or delivery service,
  - (c) a barber shop, hair salon, spa or similar business,
  - (d) a gym or other sports club, or
  - (e) any other store or business not listed in paragraph 5(1).

**8. Closure of Schools**

All schools remain closed.

**9. Restriction on visitation**

A person shall not visit—

- (a) another person's home or allow a person to visit his home,
- (b) a place of quarantine or isolation,
- (c) a patient in the hospital, except with permission from the hospital,
- (d) a person in a residential care establishment or facility; or
- (e) a detainee or prisoner in a correctional facility.

**10. Restriction on use of airports and sea ports and exceptions**

- (1) The John A. Osborne Airport shall not be used for the disembarkation of a non-Montserratian travelling by air to Montserrat from the date and time this Order comes into force.
- (2) The Little Bay Port and the Plymouth Port shall not be used for the disembarkation of a non-Montserratian travelling by sea to Montserrat from the date and time this Order comes into force.
- (3) Despite subparagraph (1) and (2), the John A. Osborne Airport, the Little Bay Port or the Plymouth Port may be used for —
  - (a) the disembarkation of a Montserratian travelling by air or sea to Montserrat,
  - (b) the disembarkation of a person travelling by air or sea to Montserrat, for the purpose of aiding in the treatment, control and suppression of COVID-19, or for the purpose of providing support to the health services,
  - (c) the embarkation of a person travelling from Montserrat,
  - (d) the embarkation and disembarkation of a member of the crew of an aircraft or vessel (including freight, cargo or courier aircraft or vessel),
  - (e) the purpose of a medical evacuation, and
  - (f) freight, cargo, and courier services.
- (4) A person who travels to Montserrat for the purpose of aiding in the treatment, control and suppression of COVID-19, must possess a medical certificate which certifies that he is not infected with COVID-19.

**11. Remote working mandatory**

- (1) An employer may operate his business by arranging for his employees to work remotely from home using electronic means or otherwise.
- (2) Except as provided by subparagraph (1) and paragraph 5, an employer shall cease operations from the date this Order comes into force.
- (3) Subparagraph (1) and (2) do not apply to an essential service provider.

**12. Public officers**

Public officers shall work remotely from home where reasonably practicable, subject to the direction of the Deputy Governor.

**13. Prohibition on a large gathering**

- (1) A large gathering for a social, spiritual or recreational activity including, but not limited to a community event; civic event; public event; leisure event; faith-based event; sporting event; parade; concert; festival; convention; fundraiser or similar activity is prohibited.
- (2) For the avoidance of doubt, a person shall not be a part of a large gathering.
- (3) The prohibition under subparagraph (2) does not apply to a large gathering at—
  - (a) a customs airport and a customs port if the purpose of the large gathering is for the embarkation or disembarkation of passengers,
  - (b) a funeral,
  - (c) a business or organisation referred to in paragraph 5, provided subparagraph (5) and paragraph 6 are complied with, or
  - (d) the business place of an essential service provider, provided subparagraph (5) and paragraph 6 are complied with.
- (4) A gathering for the purposes of a funeral may be a gathering of a maximum of fifteen persons.
- (5) As far as reasonably possible a person at a gathering shall maintain a physical distance of at least six feet from another person.

**14. Identification**

A person shall carry identification at all times and show the identification to an enforcement officer on request.

**15. Permits**

- (1) The Minister may give a person, business, organisation or Department written permission to—
  - (a) offer an essential service,
  - (b) carry out, manage or assist in a construction project,
  - (c) engage in an activity between 5 a.m. and 7 p.m. on a Monday, Tuesday, Wednesday, Thursday or a Friday.
- (2) A permit granted under the Public Health (COVID-19 Shelter in a Place) Order, 2020 (SRO 25 of 2020) continues in force as if the permit was granted under this Order.

**16. Medical examinations**

- (1) A Montserratian arriving in Montserrat from a place outside of Montserrat—
  - (a) shall answer all questions put to him by the Medical Officer which would allow the Medical Officer to assess what measures would be necessary to prevent, limit or suppress the spread of COVID-19,
  - (b) shall provide a Medical Officer with information which would allow the Medical Officer to assess what measures would be necessary to prevent, limit or suppress the spread of COVID-19,
  - (c) may be subjected to a clinical examination by a Medical Officer,
  - (d) who is considered by a Medical Officer to be high risk of being infected with COVID-19 may be isolated,
  - (e) may be required to present himself for surveillance at a place and time as may be appointed by the Medical Officer and while undergoing surveillance may be removed to a hospital or other suitable place approved by the Chief Medical Officer, and
  - (f) shall self-quarantine for 14 days commencing on the date of arrival in Montserrat; whether or not the person has symptoms suggestive of COVID-19.
- (2) A person in Montserrat who, in the opinion of a Medical Officer is likely to be infected with COVID-19—

- (a) shall answer all questions put to him by the Medical Officer which would allow the Medical Officer to assess what measures would be necessary to prevent, limit or suppress the spread of COVID-19,
- (b) shall provide a Medical Officer with information which would allow the Medical Officer to assess what measures would be necessary to prevent, limit or suppress the spread of COVID-19,
- (c) may be subjected to a clinical examination by a Medical Officer,
- (d) may be required to present himself for surveillance at a place and time as may be appointed by the Medical Officer and while undergoing surveillance may be removed to a hospital or other suitable place approved by the Chief Medical Officer, and
- (e) shall be required to self-quarantine for 14 days or may be isolated.

**17. Enforcement Powers**

- (1) An enforcement officer may stop a person and require the person to answer any question to enable the enforcement officer to ascertain the person's identity and whether the person is in compliance with this Order, and where the person does not satisfy the enforcement officer that he is in compliance with this Order, the enforcement officer may—
  - (a) direct the person to return to his home immediately;
  - (b) detain and convey the person to his home; or
  - (c) arrest the person.
- (2) The powers in subparagraph (1) may be exercised where a person is at any place other than the person's home.
- (3) An enforcement officer may use reasonable force, if necessary, in the exercise of a power in this Order.

**18. Offences**

- (1) A person who assaults, obstructs, hinders, resists, uses threatening or abusive language or aids or incites any other persons to assault, obstruct, hinder or resist an enforcement officer in the execution of his duty under this Order commits an offence.
- (2) A person who obstructs the Chief Medical Officer or a health officer acting in the course of his duty commits an offence.

- (3) A person who is present at, or promotes, aids, or assists in the promotion of a large gathering commits an offence.
- (4) A police officer may order a large gathering to disperse, and a person who fails to obey the order commits an offence.
- (5) A person who fails to comply with this Order commits an offence.

**19. Application to Court**

- (1) If a person fails to comply with an order by the Chief Medical Officer or a health officer, the Chief Medical Officer or health officer may apply to the Magistrate's Court for directions.
- (2) If the Magistrate's Court is satisfied with the application made under subparagraph (1), the Magistrate's Court may order that the person who has failed to comply be—
  - (a) taken into custody and be placed in quarantine or isolation,
  - (b) taken into custody and be admitted to, detained and treated at the hospital;
  - (c) examined by a medical officer or health officer to ascertain whether or not the person is infected with COVID-19, or
  - (d) treated for COVID-19, where on examination of the person it is found that he is infected with COVID-19.

**20. Penalty**

A person who commits an offence under this Order is liable on summary conviction to a fine of \$500 or to imprisonment for three months or to both a fine and imprisonment and in the case of a second or subsequent offence to a fine of \$1,000 or to imprisonment for a term of six months or to both such fine and imprisonment.
